Interagency Intelligence and Cyber Operations Network (ICON) [Task Order 47QFCA24F0032]

Background and Scope

ICON is a competitively awarded, 5-year Task Order under GSA Alliant 2 GWAC with multiple Technical Direction Letters (TDL) and a \$1.2B ceiling.

MANTECH is the Prime contractor on the ICON single-award contract (Period of Performance: Present through September 22, 2029), with over 70 exceptional teammates from research institutions, small and large traditional and non-traditional defense and commercial companies that span the ICON Task Areas of:

- Emerging Threats and Cyber Capabilities / RDT&E
- Integrated Intelligence
- Defensive Cyber Operations (DCO)
- Offensive Cyber Operations (OCO) Support
- Mission Systems, Networks and End User Support

ICON Objectives

The following ICON objectives provide shared and integrated resources, information and cyber capabilities across interagency partners:

- Identify, engage and implement opportunities to leverage skilled labor and technologies to advance cyber warfighting capabilities

- Reduce stovepipes and redundancies
- Gain efficiencies and transform cyber operations

Technical Direction Letter (TDL)

TDLs, similar to a Statement Of Work (SOW), specify the scope of work to be accomplished as well as other pertinent data (e.g. ODCs, travel, work locations). Each TDL is independent, under the ICON contract. MANTECH responds



to each TDL with a Technical Direction Plan (TDP) within 15 calendar days of TDL receipt. The TDP is MANTECH's plan for execution of the TDL requirements.

- Cost tracking at customer/tasking level

Key Features of ICON

- Fast, efficient process to add/change requirements via a TDL
- Flexibility: Change/modify the TDL as Mission and/or operational environment changes
- All valid funding is available for obligation (except MILCON and MILPER)
- Incremental funding for severable TDLs, cost reimbursable
- Cost-Plus-Award-Fee (CPAF) Contract Line-Item Number (CLIN) for Labor
- Cost-Reimbursable CLINs for Travel, Tools and Other Direct Costs (ODCs)
- Unclassified and Classified services (Up to Top Secret//SCI to include SAP/STO)
- CONUS and OCONUS requirements (Including in-theater and contingency operations areas)
- Cross-collaboration with IC, DoD, COCOMs, DHS, etc. executing similar missions/operations
- Compliance with Federal Government laws and regulations for small business contracting. Small business credit goes to mission partner.
- Direct access to pre-vetted industry-leading and innovative companies on the team today
- Ability to quickly add new industry partners as desired to address unique operational requirements

Value of using GSA:

- Ownership: Mission Partner has 100% control over size, scope and scale of their awarded TDL
- Mission partner provides daily oversight and direction

Process from Initiation to TDP approval can be completed in less than 45 days

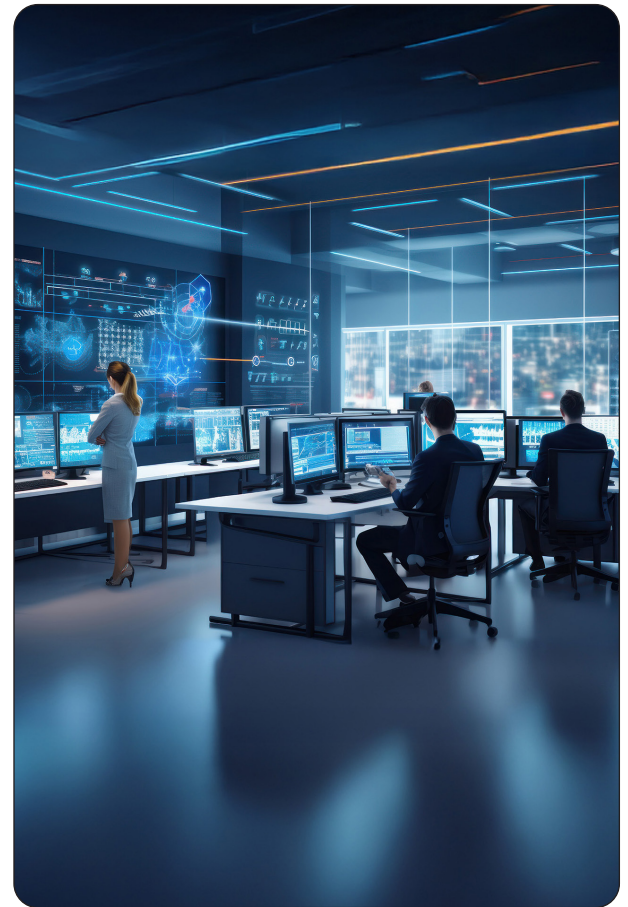
1. Mission Partner contacts MANTECH ICON POCs to gain a clear understanding of the vehicle
2. MANTECH ICON POCs connect Mission Partner with GSA AAS POC to verify desired tasking is within scope of ICON
3. GSA AAS POC converts Mission Partner tasking into a single TDL
4. Mission Partner enters into an Inter-Agency Agreement with GSA AAS
5. Mission Partner transfers funds (i.e., MIPR) to GSA AAS
6. GSA AAS Contracting Officer (CO) approves TDL and sends to MANTECH ICON PMO
7. MANTECH ICON PMO proposes Technical Direction Plan (TDP) - technical approach, cost, & schedule (15 calendar days; often less)
8. Mission Partner and GSA AAS COR approve TDP
9. TDP execution begins by pairing Contractor Team with Mission Partner
